### Special Recruitment Drive for Physically Handicapped Candidates

#### Closing Date of Application 07.06.2010

Applications are invited from citizens of India for filling up one post of Assistant (F&A) Gr.III in National Physical Laboratory (NPL), New Delhi as per details given below:-

Post & Cadre	No. of Posts	Essential Educational Qualification
Assistant (F&A) Gr.III	01 – One - Reserved for Hearing Handicapped (HH)	10+2/XII or its equivalent with Commerce as one of the subjects, and typing speed of 30 w.p.m. in English or 25 w.p.m. in Hindi.

**Note :** Hearing Handicapped means loss of 60 (sixty) decibels or more in the better ear in the conversational range of frequencies.

**Desirable:** Proficiency in typing in Hindi/English and Knowledge of Computer Operation.

**Mode of Selection:** Selection will be made through a competitive written examination comprising papers of General English, General Hindi and General Knowledge and proficiency test in Typewriting at the speed of 25/30 WPM in Hindi/English. The candidates who qualify in the competitive examination will be interviewed by the selection committee but weightage of interview will not exceed 25% of the total prescribed marks.

#### General Condition :

- Pay Band:** Rs.5200-20200 (PB-1) with **Grade Pay** Rs.1900/- plus other allowances as admissible to Central Government Employees of the same status stationed in Delhi as made applicable to the employees of CSIR/NPL.
- Selected candidates will be governed by the New Pension Scheme of the Govt. of India as has been made applicable to CSIR/NPL w.e.f. 01.01.2004.
- Age-Limit:** 18-28 years as on 07.06.2010.
- Age Relaxation:** i) Relaxation in upper age limit upto a maximum of 5 years in the case of applicants belonging to SC/ST categories; 3 years in the case of applicants belonging to OBC category  
ii) Upto a maximum of 10 years for Physically Handicapped persons as per GOI rules. For physically handicapped candidates belonging to SC/ST/OBC, the maximum age relaxation of 10 years permissible shall be in addition to the age relaxation provided in terms of column (i) above.  
iii) No age limit for departmental candidates, provided they possess the prescribed qualifications.
- Candidate should possess educational qualification and age as on 07.06.2010.
- Candidate has to give only one option of either Hindi or English for Typewriting Test and Competitive Written Examination.
- Prescribed Application form should be downloaded from NPL website [www.nplindia.org](http://www.nplindia.org). Completed application in all respects with latest passport size photograph (self attested) affixed on the application, supported by attested copies of certificates of educational qualifications, experience, caste certificate and Hearing Handicapped certificate issued by appropriate authority etc. is to be sent in an envelope superscribing **Application for the post of Assistant (F&A) Gr.III** to the Controller of Administration, National Physical Laboratory, Dr. K S Krishnan Marg, New Delhi – 110012, so as to reach on or before **07.06.2010**. **Application should be in the prescribed format will only be accepted, no other mode of application will be accepted.**

Applications from candidates working in Government Departments/Public Sector Undertakings/Autonomous Organisations will be considered only if forwarded through proper channel and with a clear certificate that in case the applicant is selected he/she will be relieved within one month on receipt of the appointment order.
9. Late applications/incomplete applications/unsigned applications/interim enquiries will not be entertained. Bringing in any influence, political or otherwise shall be treated as disqualification.
